2. WP1: 1st draft of curriculum

Partners agreed to finish the first draft of curriculum by 15/04/2020. The draft will include the following elements: Name of the course, year of study, ECTS points, teacher, learning outcomes, etc.

Every partner is developing their own study program of IAR. These study programs can be different, but at the end they must lead to the same competences of their graduate students as future IAR professionals.

Kazakh partner universities will use the help and expertise from our project partners from Europe (FHJ, DHBW, UNS).

Draft versions of curriculums can be made in Kazakh and Russian languages. Final version of curriculums will be translated into English (only main parts). All three versions of every curriculum will be published on the project website.

3. WP1: Meetings with companies (World cafe)

Kazakh partner universities will organize meetings with their partner companies. The meetings can be organized online if it is not possible to arrange live meetings. Every university can have more than one partner company and more than one meeting. The idea is to send the draft curriculum to companies and then discuss all the elements of curriculum with representatives of companies.

After every meeting, partner university must make a report about the meeting and what are the conclusions about the curriculum.

The deadline for this activity is 15/05/2020.

4. Purchase of equipment

Since KEEU and INEU are private universities, they can buy equipment directly, without public procurement. They will collect three offers each and select the best one. In the case of WKATU as public university, public procurement will be organized.

All document about the purchase must be saved, scanned and scanned version must be sent to coordinator.

As soon as Kazakh partner universities give the proof to coordinator that equipment is in their premises, the coordinator will transfer the funds for equipment to KEEU, INEU and WKATU. This is according to partnership agreement, article 6.2.2.

After the public purchase is over, report about purchase of equipment will be made by INEU, as the leader of work package 2.

5. Change of work plan due to Covid-19 pandemic and registration/accreditation procedure in Kazakhstan

The conclusion is to finish with first version of curriculum and than take further steps.

Participation of lecturers from Europe in study programs of IAR in Kazakhstan will raise the quality of teaching and exchange of knowledge. Therefore, Kazakh universities will contact FHJ, DHBW and UNS to clarify on which courses teachers from Europe can participate. During the project, consortium can finance their trips for teaching in Kazakhstan, and afterwards Erasmus Mundus scheme for teachers' mobility can be implemented.

6. Schedule of study visits: Graz, Heilbronn, Pavlodar



As soon as pandemic crisis is officially over, Kazakh partners will apply for visa and first study visit (probably to Graz) will be organized.

7. Subcontracting expenses – explanations and clarifications

Professor Savic has introduced the Kazakh partners about EACEA rules regarding subcontracting. At least at the beginning, if any partner wants to use subcontracting, coordinator must be consulted in order to avoid and ineligible costs.

8. Synergy effect – Nomination of contact person for every partner

Coordinator invited Kazakh partners to look for other Erasmus+ projects in order to exchange the project results and obtain synergy effect between projects.

9. List of events – Determination of new deadline and contact person

Every partner must make the list of events where DIARKAZ project can be promoted in the next 12 months. All partners in Kazakhstan will finish the list of events until April 10th.

10. Registration of UTP as new project partner

Registration of UTP (Uralsk Transformer Plant) on the website of EACEA and validation of PIC number is on its way. Until then, coordinator will send the PA and mandate letter to be prepared on time, so that UTP representatives can travel with other partners to our study visits.
